

# **BROKERAGE ACCOUNT AGREEMENT**

#### 1) TERMS OF USE

These Terms of Use (the "Agreement") are applicable to the: (i)web pages, (ii) services, (iii) content, (iv) databases and (v) information (collectively referred to as the "Services") together with the agreements and software provided by **Merlion Global**. (hereinafter called "**Merlion Global**")to which you may have access by using Merlion Global's website or, upon request, in hard copy. ## 2) AGREEMENT
